PART I. General Expectations

Pleasant Valley agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required campus Title I Parent Engagement Plan meet the requirements of section 1118(b) of the ESEA, and include as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

PART II. Description of how Pleasant Valley will implement the required components of the campus Title I Parent Engagement Plan.

1. Pleasant Valley will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - To increase parent accessibility and participation, these meetings will be offered at Pleasant Valley Elementary School in the library. Prior to reviewing, discussing and amending the plan, the school will offer parents' training on what Title I entails and the importance of parent input.

2. Pleasant Valley will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - Parents will be selected based on their level of participation within the school. Training on the Plan requirements will be provided.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - Staff training will take place during professional development meetings.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Pleasant Valley will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Back to School Meet and Greet
- Title 1 Open House
- Donuts for Dads and Muffins for Moms
- STAAR information meetings

4. Pleasant Valley will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's

curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- Parent Teacher Conferences

5. Pleasant Valley will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible.

These may include, but are not limited to, the following:

- Parent Information meeting during the summer month of June
- Parents as Partners meetings six times throughout the year
- Parent involvement survey

6. Pleasant Valley will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Parents are notified of State Assessment results through call-outs and flyers sent home before school lets out for the summer.
- These notifications list how parents can access their child's STAAR results electronically.
- Parents may schedule individual parent conferences as needed.

7. Pleasant Valley will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey.

8. Pleasant Valley will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Discovery Center Night.
- Skyward Parent Training.
- Parent engagement programs (e.g., Parenting Partners, Parent Collaborators, Love and Logic, Latino Family Literacy Project, Strengthening Families, Parent Empowerment Program, etc.).

9. Pleasant Valley will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Parents as Partners Training.
- Faculty and Staff Meetings on Parent Engagement

10. Pleasant Valley will, to the extent feasible and appropriate, coordinate and integrate TI parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Back to School Night
- Parent/Teacher Conferences before the end of the Fall Semester

11. Pleasant Valley will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Providing interpreter and translation services at meetings where a reasonable extent of parents speak a language other than English, provide services upon request, use the language line, etc.).
- Translation services for parent contacts in regard to student concerns.

PART III. Discretionary Components of the Pleasant Valley Title I Parent Engagement Plan
